NATIONAL ENVIRONMENTAL INFORMATION SYMPOSIUM

The first National Environmental Information Symposium of the U.S. Environmental Protection Agency will be held at the Cincinnati Convention Center, September 24-27. The symposium will bring together producers and handlers of environmental data

to identify and explain resources and methods to users. Information will include the scientific and technical; legal, legislative and regulatory aspects. It will feature data centers and publications and 300 exhibits. Registration, made payable to the U.S. Environmental Protection Agency, is \$15.00 until September 1 and \$25.00 thereafter.
