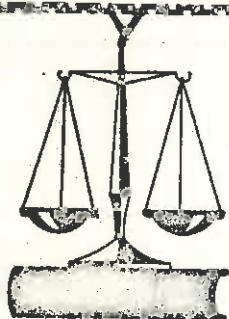

ABOUT OUR LIBRARIES
SALMON P. CHASE COLLEGE OF LAW LIBRARY
NORTHERN KENTUCKY UNIVERSITY

In 1893 the Cincinnati and Hamilton County Young Men's Christian Association established a night law school. The College of Law remained a part of the YMCA until July, 1951, although association with the YMCA was retained until 1968 and the college continued to use its quarters until 1971. In July, 1972, the College of Law merged with what is now Northern Kentucky University and moved into its present facilities on the edge of Covington, Kentucky, overlooking the Ohio River. In 1975 the College of Law established a day division in addition to its evening division.

The law library, operating under the management of professional librarians since 1971, serves 21 full-time and 15 part-time faculty, and 600 students. 160 local attorneys and Kentucky citizens are also registered with the library as regular users.

Chase Library houses approximately 80,000 volumes in hard copy and 40,000 in microform. The library has a good collection of records and briefs including the United States Supreme Court Records and Briefs, Ohio State Supreme Court Records and Briefs, Sixth Circuit Records and Briefs and Kentucky Supreme Court Records and Briefs.

The library staff is organized into two main departments and is headed by John M. Lindsey, Professor of Law and Director of the Law Library. Beth Gwynn, Associate Law Librarian, is charged with the development of reader services and Andrew Brann with the development of technical services. Carl Yirka, Reader Services Librarian, Martha Fischer and Pam Pollitt, both part-time Reader Services Librarians, complete the professional staff. Nancy Buchanan, Head of Circulation and Wilma Hutchinson, Head of Acquisitions, Carla Behymer, Assistant Cataloger, Karen Mayer, Acquisitions and Serials Technician, Donna Trenkamp, Cataloging and Classification Technician, Roger Franxman, Reader Services Assistant and Roberta Brinkley, library Administrative Secretary, compose the paraprofessional staff. In addition, the library staff is assisted by three part-time students.

One of the library's main accomplishments during the past year was the development of an extensive information up-dating service customized to each faculty member's interests. Other library projects this year involved publishing a Users Guide to the library and directing a Basic Legal Research Workshop for legal secretaries in Northern Kentucky. Chase Library staff also teach basic legal research skills to graduate students from other local universities in the spring and summer of each year.

Chase Library welcomes interlibrary loan and reference requests from other libraries and individuals. Operating hours are 8 a.m. to 11 p.m. Monday through Friday; 9 a.m. to 11 p.m. Saturday and Sunday. The phone number is (606)292-5395.

RECOMMENDATIONS OF AD HOC COMMITTEE ON THE NAME OF THE ASSOCIATION

The Ad Hoc Committee on the Name of the Association was formed this year to deal with the continuing discussion on whether the name of our organization ought to be changed. The committee was composed of a representative from each of the major states in ORALL: Betty Busch, Ohio; Peggy Fisher, Michigan; Beth Gwynn, Kentucky; and Wendell Johnting, Indiana. Each person was asked to survey the ORALL members in his/her state and answer two questions: should the name of ORALL be changed to something more descriptive of the entire membership, and if so, to what?

According to the four representatives, the response was overwhelmingly in favor of changing the name. (The reasons for this have been detailed in the March 1977 issue of the ORALL newsletter, so there is no need to repeat them.) As to what the name ought to be, two suggestions were most prominent; either Great Lakes and Ohio Valley ALL (GLOVALL) or Mideast Regional ALL (MERALL).

So, the recommendations of this committee are that

1. the name of ORALL be changed, and
2. the members, in voting on the name change, should have a choice of three:

GLOVALL
MERALL
ORALL

Certainly the name change would not and, for that matter, probably could not be done immediately. But over the next year or two, the stationery could be used up, other groups would become accustomed to our new designation, and gradually our new name will be a valuable change in our organization.
