LEGAL RESEARCH

Condyne/Trans-Media Distributing Corp. has published an audio tape presentation edited by Betty W. Taylor, Professor of Law and director of the Law Library at the University of Florida. Audio Research in the Law, Series One: Basic American Law consists of five cassette tapes, which run for approximately three hours, and a complementary treatise.

Indiana News

FOR IMMEDIATE RELEASE ---

James F. Bailey, Director of the Law Library and Associate Professor of Law at Indiana University School of Law, Indianapolis, has been named chairman of the Law School's Building Committee. The task of this committee will be to investigate possibilities and draw up the plans for long-term law school expansion, particularly an extensive new wing on the present building. As the largest and fastest growing law library in the state of Indiana, the I.U. School of Law Library will soon be out of maneuvering space, and the situation calls for long-range planning in this area. The library collection already exceeds 260,000 volumes, and growth has accelerated in the last few years.

A new librarian has been added to the Indiana University's staff. His name is Merlin Whiteman and he comes to IU from the Detroit area where he was the Adult Services Librarian at the Bacon Memorial Public Library in Wyandotte, Michigan since 1974. He has an MLS from Indiana University and has completed 1 and 1/2 years of law school at Detroit College of Law. His title here is Readers Services Librarian.

Sylvia Castano has left IU to move to Houston, Texas. She was married in June and will be starting law school this fall at the Univ. of Houston Law School. She was previously IU Readers Services Librarian and also chairman of the Union List of Serials Committee for ORALL.

James Bailey was a speaker at the Indiana Continuing Education Legal Forum Institute on Appellate Practice in April, 1979. The title of his talk was "Researching the Issue to be Appealed and a Review of New Research Tools."

Kathy Welker was a speaker at the Reference Roundtable of the Indiana Library Association on the topic of "How to Use Legal Reference Materials" in May, 1979.

INDIANAPOLIS LAW CATALOGING CONSORTIUM ON PLANNING BOARD

Several law firm libraries in Indianapolis and the Technical Services Division of the Law School Library, Indiana University-Indianapolis, are in the planning stages for an Indianapolis Law Cataloging Consortium.

The Consortium will be composed exclusively of law firm and legal organization libraries desiring to have their cataloging done utilizing the OCLC system. Only texts, treatises, and looseleaf services will be cataloged during the first phase of this project; however, original cataloging will be provided for items not represented in the data base. The service will be a centralized operation, with participating libraries sending OCLC/INCOLSA request forms to the Law School Library. Cards sets will be produced from the law school's terminal and mailed directly to the requesting library from OCLC in Columbus. Labels for book card, pocket, and spine will be printed on the law school's Terminet 120 printer and shipped to libraries.

In the area of auxiliary services, a quarterly acquisitions list will be provided for interested members. There has also been discussion concerning the establishment of a union catalog based on the cataloged items produced through the consortium.

This consortium hopefully will be an important contribution to law firm libraries in the city, since they will receive qual-

ity cataloging, as well as saving money by sharing First Time Use and labor charges.

Ohio News

The University of Cincinnati College of Law and Marx Law Library began an expansion and renovation of their present structure in June, 1979. This is part of a project that includes both the law school and the library at a cost of \$9,233,981.00. The first part of the multiphase operation will be the construction of a new 250,000 volume library facility. Completion of the basic library unit is expected in the Spring of 1981.

The new library facilities will follow the concept of a multiunit library: basic, faculty, law review, moot court, and legal clinic libraries all in the same building. Another important feature of the new library will be the reserve section with capacity for 10,000 volumes in closed stacks. The rest of the collection will be placed in open stacks.

Jorge L. Carro, Head Law Librarian and liaison between the College and the contractor has been the catalyst for the ambitious program which is now underway. He invites ORALL members who happen to be in the vicinity to stop by his office and take a look at the architectural model and photographs.

PROPOSAL--

"Legal resources in public libraries"

Anita Shew, Butler County Law Librarian presented a proposal for creating an Ad Hoc Committee called Legal Resources in Public Libraries to the members at The Fall ORALL meeting at Kings Island, October 11, 1979.

The response to this proposal by members after the meeting and by letters afterwards has been indicative of the interest by our members. ORALL President Kathy Welker has indicated that the Executive Board will approve the creation of this committee.

Basically, the concept of public access to legal information has grown out of concerns in Ohio with the Ohio Legislature's attempting to open county law libraries to the public, out of programs by the Canadian Law Council and various state groups to provide the public with general legal information, and out of the awareness of the strain public need for legal information has put on all kinds of specialized libraries (academic, state, county, etc.)

The committee would follow the direction of the Michigan Assoc. of Law Libraries (before the AALL meeting) of sending a survey to public libraries in Ohio to solicit information about their legal collections and patron needs. This committee would prepare, send, and evaluate the survey; revise the Ohio Model Bibliography as a resource to the public libraries; investigate the need for training sessions for public reference and circ. librarians; coordinate any further efforts for public awareness of legal information. Mrs. Shew has been in contact with the State Library of Ohio and there is a real possibility of getting a grant for various aspects of this endeavor.

MOST PROJECTS OR PROGRAMS ARE THE RESULT OF REACTION TO A GIVEN PROBLEM. THIS PROPOSAL IS AN ATTEMPT TO MEET A NEED BEFORE IT CAUSES A PROBLEM FOR ANY OF US.

Exec. Dir. of AALL

The AALL wants all members to be aware of the proposed establishment of an Executive Director for AALL. The following statement briefly summarizes various considerations that were submitted to the Executive Board, January 3-4 in Phoenix:

Some months ago, the Executive Board authorized the establishment of an Ad Hoc Committee to again address the question of whether the office of Executive Director for the American Association of Law Libraries should be established. Shortly after the San Francisco convention, the following committee appointments were made:

The proposed final draft of the committee report has been prepared and a final report will be submitted for Executive Board consideration at the mid-winter meeting in Phoenix on January 3-4, 1980.

The report is most positive in terms of recognizing a manifest need for an Executive Director--as have several other study reports in past years--and recommends specific funding proposals. The following statement briefly summarizes both the considerations addressed by the committee and the recommendations which will be presented to the Board. That this is the singularly most important administrative action recommended to the membership of AALL since the

establishment of headquarters in 1964, there can be little legitimate debate. Consequently, membership participation and input is indispensable. Comments are actively solicited and may be made directly to any Officer or member of the Executive Board, or the President of your local chapter who will then convey those comments to the Board.

Need:

Since early 1965, the AALL has been admirably served by its headquarters in Chicago, established at that time to manage the Association's routine business. AALL could not presently function without this valuable office now serving a membership of over 3,000--more than twice the membership when headquarters was established. As an Association, we have been especially fortunate in the management of this operation with dedicated and expert employees in painfully small numbers and at a modest total operating cost.

Established to provide continuity in the routine, day-to-day operations of the Association, headquarters is able at present to supply little else. As the Association has grown, and as library concerns have become infinitely more complex, so have the issues that confront AALL membership. Continuity of routine operations is one thing; however, positive, vigorous and continuous management of issues confronting the membership in matters of professional policy is quite another. AALL remains alone among major U. S. library associations without the continuing professional direction supplied by an Executive Director. As a result, the continuity of national library policy and policy-making often passes us by. Ideally, our Presidents should fill this role, but with the ever-increasing number of items competing for attention during a tenure of only 12 months, this is simply not possible, no matter how articulate or dedicated the President may be to the Association's interests. There are critical areas of legislation, library policy and professional activity that are neglected due to the absence of a continuous executive authority, subject to the AALL President and Executive Board, who can speak on behalf of the Association as required.

Surely any recent President of this Association would agree with Morris Cohen when he said in 1972:

"The conscientious efforts of the headquarters staff make the President's job... much easier, but this outgoing President felt even more strongly that real progress in Association growth and influence requires the appointment of a fulltime professional executive director."

The services which could be provided by an Executive Director are many and varied. With membership direction, the Executive Board must establish priorities and delegate appropriate authority. Hopefully, the primary duties and responsibilities would be directed outwardly to address those problems facing today's libraries on a national scene and which involve interaction with other associations and government rather than directed inwardly toward the bits and pieces of internal administration. These daily administrative functions are being presently met in a most efficient and professional manner by our present Administrative Secretary and should so continue.

The energies of an Executive Director could be, for example, very effectively utilized in monitoring federal legislation and lobbying on behalf of AALL in areas of our interests. Likewise, efforts should be devoted to creating strong relationships at the decision-making administrative level with national associations such as ABA, AALS, ASIS, ARL, ALA, ASIL, IALL as well as numerous others. Certainly, however, certain specific internal functions must receive his energies and attention, such as convention planning--which is rapidly outgrowing the "local arrangements" structure--and continuing library education/certification.

Costs:

AALL cannot afford an Executive Director on a grand scale; cost and income studies and projections, however, indicate we can afford the office on a more modest basis with the recognition that astute

and conservative fiscal management must be the general standard throughout.

Cost estimates to establish the office range from a workable, but close margin, budget of \$63,000 to a budget of approximately \$79,000 which would provide more flexibility. Both budgets will be presented to the Executive Board with the recommendation that the lower one be adopted.

It is an immutable fact that income to meet basic costs must come from assured regular Association sources--dues and investment income. Should an Executive Director be hired, it is reasonable to assume that additional and diversified funding resources could be developed under his direction, such as public/private grant funding and actively working toward the development of an endowment fund. Initially, however, it is not reasonable to assume these resources will be available.

As of August 27, 1979, AALL membership totaled 3,002, generating annual dues income of approximately \$114,000. The membership includes 115 student members (\$10 dues), 181 life members (no dues), and 1 honorary member (no dues). A dues increase of \$25 for the remaining 2,705 active, institutional and associate members would generate additional annual revenue of approximately \$67,625. Student and life memberships would remain unchanged. The committee will submit to the Executive Board an alternative method of funding which proposes a two-step increase--\$15 per year for both FY 1980 and FY 1981.

Other professional associations realized an increase in membership and revenue base shortly following the hiring of an Executive Director. While it is anticipated this would be the case with AALL, it should be recognized that an initial start-up period of 2-3 years should be anticipated before any Executive director could be realistically expected to increase Association revenue through the efforts of his office. Assuming the low budget figure of \$63,000, the proposed dues increase would fund the office, with built-in projected inflation, without diverting monies from other existing Association activities or needs.

Summary:

The time has long since past when AALL began to be seriously injured on the national library scene by not having the administrative continuity required to operate as an effective, viable and positive force. The eventual decision will, of course, be made by the general membership; your thoughts, ideas and suggestions are seriously solicited by the Officers and Executive Board.

CAPITAL UNIVERSITY'S

"BIG MOVE"

Like many law schools these days, Capital University Law School just moved into a new household. Josiah H. Blackmore, Acting Dean and Professor of Law rallied 500 volunteers to help move some 110,000 law books.

The big move was from Capital's East Main Street Campus in Bexley to a down-down building. The downtown location is seen as a plus since it is in the heart of the legal community. The students are within walking distance from county and municipal courtrooms and will be able to observe legal structure firsthand. Lawyers will also benefit from the new location since the law school is looking into continuing adult legal education.

The building was previously the Grange Mutual Company's Insurance headquarters. They signed a 10 year agreement of rent-free use of the three story building. The University though, has spent approximately \$1.5 million to remodel and create classroom space. They have even enclosed a previous driveway to make an 80 seat tiered classroom.

This new law school move is a homecoming of sorts. Previously, it was the site of the First Evangelical Lutheran Seminary, the forerunner of Capital University.
