To hopefully address these questions, Mike Whiteman is chairing the Bylaws Committee this year to give them all the once-over. Have you noticed anything in the Bylaws that you think needs attention? Please send me your concerns – I would be glad to hear them.

Although the 2010 annual meeting held in Canton, Ohio may be but a memory for those who attended, ORALL has made an impression that will last forever.

Several members who toured the National First Ladies' Library, Education Center and Saxton House during the conference were so impressed that they inquired of ORALL whether we might as an organization leave a permanent reminder of our meeting in Canton. The answer: Yes!

Following the October meeting, Treasurer Rick Goheen received donations from seven ORALL members: Angela Baldree, Carol Bredemeyer, Rick Goheen, Carol Hudspeth, Mary Jenkins, Steven Probst, and Cindy Seaton. To help bring their benevolence to fruition, the Local Arrangements Committee-Canton recommended and the Executive Board approved using surplus from the Canton meeting to help secure a donor plaque.

The outcome: A naming contribution was made to purchase a commemorative donor plaque for a seat in the National First Ladies' Library Education and Research Center Theatre. The Education and Research Center Theatre is used for programs to further educate about the history of our country, the contributions of First Ladies and the significance and contributions of women throughout history.

The plaque finally arrived and was mounted to a theatre seat in March 2011, and we have the pictures to prove it! The National First Ladies' Library is so pleased and sincerely appreciates ORALL's donation. Kudos to ORALL and its members for their contributions and desire to further support Mrs. Regula's vision.

Delaware County, Ohio Hosts Interfaith Legal Services Clinic: Or, Why the Librarian is Smiling.

Do you ponder what to do with patrons who have no working knowledge of how to use a Table of Contents or an Index, let alone a computer database? Are you tired of people asking you for "the form"? Do you cringe when someone prefaces their question with, "they told me at the Court House that you would help me"? In Delaware County, Ohio, we are partially addressing these issues with a free legal advice clinic.

As the budget for the Legal Aid Society was cut, the population of Delaware County was growing and the number of *pro* se parties increased at the Courthouse; as a result, the need for additional legal resources for these litigants was evident. In 2003 the Delaware County Bar Association, the Delaware Ministerial Association and the Ohio Legal Assistance Foundation launched a free legal advice clinic, the Interfaith Legal Services Clinic (IFLS) in cooperation with the Andrews House, a local community services center.

On the third Tuesday of each month a cadre of volunteers arrives before 5:00 p.m. at the Andrews House to set up tables, put out homemade baked goods, and organize the paperwork. Clients are invited to arrive between 5:00 p.m. and 6:00 p.m. to answer brief intake questions. The target population is Delaware County citizens at or below 250% of poverty income. However, people from the surrounding counties of Franklin, Marion and Union have received advice and the "working poor" are not turned away. When the volunteer attorneys arrive the intake sheets are matched to the attorney's area of expertise and the client meets privately with an attorney. Usually the attorney-client conference lasts about 30 minutes, but if a matter is complex it may run longer. If a client's matter cannot be resolved with a consultation, they may be referred to the local Legal Aid office, an attorney may agree to further handle a matter *pro bono*, or a referral to another attorney (e.g. bankruptcy, social security disability) or resource (e.g. Public Defender office) may be made.

In 2008 the IFLS Clinic served 92 clients and in 2009 served 168 clients; an increase of 83%. We believe this dramatic increase was the result of the "Great Recession". In 2010 the IFLS Clinic served 206 clients in eleven sessions; an increase of 23% from 2009. (Note: The February 2010 IFLS Clinic was cancelled due to a snow storm and probably 20 additional clients were missed as a result). During the three nights of operation in 2011, IFLS Clinic volunteers have served 55 clients.

In 2009 the IFLS Clinic received the Outstanding Program award from the Ohio State Bar Foundation. The OSB Foundation gives this annual award to "a non-profit organization, agency, government entity, association or program of any of the foregoing, that is consistent with the mission of the Foundation and promotes the dissemination of public information, improvement of public understanding and enhancement of public education concerning our system of justice and how it impacts the citizens of Ohio".

Columbiana County Law Library Passes Torch as Jan Morley Retires

After a long and remarkable career as a county law library director, fellow ORALL member Jan Morley retired from the Columbiana County Law Library on March 18th. Her assistant of four years, Ron Vest, will be her successor at the law library in Lisbon, Ohio.

Jan first began her service as a law librarian in Steubenville where she managed the Jefferson County Law Library starting in 1988. Although the library was small with minimal funding, Jan's diligent business practices enabled it to have a well-rounded print collection and modern technology.



In 1999, Jan saw the chance to help another county law library in real need of assistance. The Columbiana County Law Library was without a librarian for a short while. Supplements and financial matters were becoming backlogged. Feeling up to the challenge and ready for a change, Jan accepted the law library director position. In no time, she had the library back on track and operating in good fiscal order.

When Jan first moved to the Columbiana County Law Library it was located in the cramped quarters of the courthouse basement. In 2003 the bank building across the street became available, so the law library association opted to move the library to these more spacious accommodations.

Moving a library is a huge undertaking, but Jan was very enthusiastic about the idea of having what she called a "real" library - complete with meeting rooms, computer areas, plenty of storage and genuine oak shelves and tables. With the help and guidance of board member, Judge Thomas Baronzi, Jan worked

industriously to make their vision of a new law library a reality. It is now a great asset for the legal community of their county and the surrounding areas. It is also a reflection of Jan's sensible character - both tastefully decorated and practically designed to offer the most effective environment for legal research.

In addition to her abundant skills in operating a law library, Jan has always been involved in organizations where she felt she could make a difference. Over the years, she was an active and outspoken advocate of county law library affairs, contributing wholeheartedly to whatever issues they have faced. Her great compassion for the county law libraries shows in her work with ORALL and the County Law Library SIG.

Jan's remedy for overcoming law library issues was through learning and communication. Therefore, as SIG Chair in 2001, it was very important for her to hold a spring retreat where all the county law libraries would have the time to exchange their views and learn new ideas. It was a two-day event with plenty of classes, good food and even entertainment.

Inspired by the favorable outcome of her SIG meeting, Jan hoped to provide a similar affair for ORALL before she retired. Last year's conference in Canton gave her this opportunity. Between Jan's talent for obtaining financial support and Co-Chair Beth Langton's eye for detail, the conference was bound for success.

The County Law Library SIG will miss Jan's active involvement and creative ideas, but we wish her well on her next endeavor. In retirement, Jan is planning to have more time to spend with her husband, Bob, and other family members. She and Bob are planning a trip to their favorite vacation spot – Ocracoke Island, where Jan is an avid seashell collector. They also will be enjoying their time fishing and boating at their summer home on Guilford Lake.
