## The Right People in the Right Places

#### A Fresh Perspective\*

I recently interviewed for a position other than the one I currently hold. (Don't worry Toledo, I'm not going anywhere!) I did not get the job, but I did gain some new perspective on the one I already have.

I wouldn't recommend doing this just for the perspective – it's generally not a good idea to apply for jobs you have no intention of accepting if an offer were to be made – but if the interest is genuine on both sides, you can learn a lot from each other.

Updating your resume or CV is an opportunity to reflect on who you are, where you've been, how you got to where you are now, and where you'd like to go in the future. Keeping the resume up to date is a good idea anyway, because you never know what else you might need it for, e.g. a program speaker biography (hint, hint...), or an officer candidate statement. Writing a cover letter is a chance to explore your strengths and weaknesses, and to think about your

skills and experiences and how they might fit into a new and different place with new and different people.

Preparing for an interview, whether it's by phone, Skype, WebEx, or on-site, gives you an opportunity to use your brain in a different way. The interview is, of course, an opportunity not only for them to learn more about you, but also for you to learn more about them. It's not just the people you want to learn about, it's the whole structure — organizational, physical, and financial.

#### Law Library Website Security: https By Kathleen M. Dugan, Cleveland Law Library

Introduction: In July of 2018, Google announced that after two years of planning it was beginning to mark all website URLs that were not encrypted with https as "not secure" in the Chrome browser. 1 Up until then, our Law Library had not felt any significant pressure to convert our web pages from http to https by purchasing an SSL Certificate. We honestly felt that we were employing sufficient security precautions against Internet security breaches, and the change was only going to affect Chrome users anyway. I also took an informal survey of Ohio County law library websites (or their County portals) and learned that only about half of those websites were encrypted with https at that time.

However, we realized that many of our patrons use Chrome, and Chrome enjoys a market share of at least 56% among Internet browsers.<sup>2</sup> Inasmuch as we did not want any patrons or potential patrons to view our web pages as unsafe, we decided to take the time and spend the money to purchase and install an SSL certificate to make our entire website secure during National Cybersecurity

Month last October. Since our Library's Network Administrator and I are both self-taught techies, I thought I would share our journey and a few tips.

Technical terms: For those considering moving to https, there are just a few technical terms to remember. The acronym http stands for hypertext transfer protocol. In simple terms, these are the standards or procedures which govern Internet communications between computer servers and Internet browsers. Servers are computers that run law library networks and send information to other computers, and browsers are software programs that allow patrons to search the Internet and display law library web pages. The addition of an s in https at the beginning of a law library's website address signals and guarantees that communications between the library's website and patrons' browsers are encrypted and that the website is secure. Stated otherwise, the s assures your patrons that your law library's website is the genuine location of your library's online presence and not a fake or spoofed site. Everyday examples you may encounter that employ https include online banking portals and many e-commerce websites.

Why convert to https: There are a few very important reasons to convert your law library's website to https, chief of which is increased security. Although you should still install other website security tools such as anti-virus software and firewalls, using https makes it much more difficult for hackers to decrypt Internet communications between users and your website.

The second reason is the enhanced credibility an *https* web address can provide for your law library. Since many of your patrons and potential patrons will use Chrome to find and search your law library's website, migrating to *https* will prevent them from seeing the phrase "not secure" in the address line for your library and wondering whether your website, or worse yet your law library, is suspect. Instead, they will see a padlock icon  $^{\triangle 3}$  that will lend trustworthiness to your website and convey the message that you respect users' privacy and security.

A lesser-known reason to convert from *http* to *https* is that Google is giving a slight priority to *https* websites in search result rankings. Experts differ about the actual boost *https* websites receive, but Internet search results can often be so large that every little bit can enhance your SEO (search engine optimization) and help make your website more visible to searchers.

The basics of converting: To employ the https protocol and make your website secure, you will need to take several steps. First, you will need to purchase a Certificate for use with SSL (Secure Socket Layers) or TSL (Transport Layer Security) protocols. These are sometimes referred to as SSL Certificates or TSL Certificates, and one can be purchased from the domain name provider that you

use to register your website address. Our vendor is Network Solutions, and our first year of *https* security cost our Law Library \$139.00.

The next two steps involve activating and installing your new Certificate on your web server. After that, you will need to change all of your law library's web pages from *http* to *https*. This step can often be performed once, or globally, for all of your *http* pages, similar to the replace feature in a word processing program. Finally, you will need to redirect all incoming Internet requests that are looking for your old *http* pages to their new *https* equivalents. These instructions are called SEO 301 redirects. Although this may not be a totally DIY project, with a little technical assistance from Internet videos, help sites, and your domain name provider, you can accomplish it all in a few days, including a little wait time between steps.
